Supported construction on churches, housing, or the Mayan Children's Village, in cooperation with teams of volunteers from U.S. churches or schools. Projects were in selected villages scattered throughout the Yucatan Peninsula of Mexico. They built or improved homes for poor families; or worked with Mexican Presbyterian congregations on building or improving church facilities; or one team completed improvements to the Mayan Children's Village. In 2008, 13 teams completed projects in 11 different villages in 4 states (Yucatan, Campeche, Quintana Roo, and Chiapas).

4b (Code:) (Expenses \$ 57,151 including grants of \$ 57,151) (Revenue \$ None)

Supported the operation of the improvements to the Mayan Children's Village which housed Mayan children who would otherwise be unable to attend upper grade school through high school. The Village provides a home, including room, board, and supervision that involves the children in mental, spiritual, physical, and service activities. It is effectively an orphanage for a few. It is located near El Ideal, Quintana Roo, Mexico. In 2008, the Village was home to 18 children and a van was purchased for transportation.

4c (Code:) (Expenses \$ 38,603 including grants of \$ 38,603) (Revenue \$ None)

Supported the operation of and improvements to the Boys' Shelter in Merida, Mexico which housed young men who would otherwise be unable to attend higher education. The young men attended colleges and seminaries, studying for engineering, theology, tourism, business, education, or other degrees. The Shelter provides a home, including room, board, and supervision. Occasionally, tuition scholarship is also granted. In 2008, the Shelter housed 14 young men and one scholarship was granted.
