Supported the operation and improvements to the Mayan Children's Village, in continuous operation since 2006, which housed 15 children (4 overnight and 11 day students) providing a safe space for young high school students to eat, study, fellowship, and sleep as needed; providing an alternative to the increasing pressure from gangs. These students would otherwise be unable to attend high school, due to lack of transportation. The Village is effectively an orphanage for a few, and is located in EI Ideal, Quintana Roo, Mexico.

4b (Code:) (Expenses \$ 106,093 including grants of \$ 0) (Revenue \$ 0)
Supported the operation of and improvements to the Merida Student Houses which house students who would otherwise be unable to attend higher education. The Men's House has been in continuous operation since 1995 and The Women's House since 2021. These facilities continue to provide a safe and nurturing environment for young people to further their university educations through professional licensure. In 2025, there were 14 men and 10 women in these programs, maximizing use of the facilities. In addition, in 2025, 5 scholarships (3 for men and 2 for women) were provided for school fees and expenses. Both houses are located in Merida, Mexico.

Supported construction and improvements on churches, ministry facilities or housing, in cooperation with teams of volunteers from U.S. churches. Projects are in selected villages scattered throughout the Yucatan Peninsula of Mexico. The 2025 improvement projects focused primarily on the village of Piste at a local church. In 2025, three teams, comprising 52 volunteers, completed those projects.
